The level 5, 6 & 7 is a qualification that was devised in order to standardise the quality and content of the training available to practitioners of non-surgical aesthetics procedures. Tighter general regulations on non-surgical interventions were implemented after a report by Health Education England (HEE) outlined the required levels of competence for all treatments in the industry.

A regulatory framework was created collaboratively between a number of associations, enforced by two independent bodies – the Joint Council for Cosmetic Practitioners (JCCP) and the Cosmetic Practitioners' Standards Authority (CPSA.) In simple terms, this means that there are more stringent general regulations about to come in place, limiting those who are able to satisfy the necessary standards for practice to those who are suitably qualified, and thereby increasing the safety of patients.

WHAT IS IT

The Level 5, 6 & 7 aims to provide an industry-standard qualification in a currently under-regulated sector. Through an intensive mix of practical and theoretical coursework, delegates are armed with the tools they need to begin their career in aesthetics.

The rationale of the programme is to provide a career path for learners who wish to develop their aesthetic practice capabilities within the health and aesthetic sector. The expected outcome of the certificate, which is the achievement of a recognised UK qualification, is for learners to develop the skills required by organisations and the aesthetic industry globally.

It's expected that the Level 5, 6 & 7 qualifications will soon be recognised as the mandatory minimum level of certification to practice aesthetics legally.

However, its not just about staying compliant; it's about being at the forefront, mastering the nuances of aesthetic medicine, and becoming the best version of oneself as a practitioner. IS IT MANDATORY

Currently, the regulations set out regarding requirements for practising aesthetic medicine are lacking. However, tighter general regulations on non-surgical treatments were implemented after a report by Health Education England (HEE) outlined the required levels of competence for all treatments in the industry.

Because of this, it is an industry-wide expectation that professionals administering non-surgical injections should have completed the Level 7 qualification. This is equivalent to a postgraduate degree.

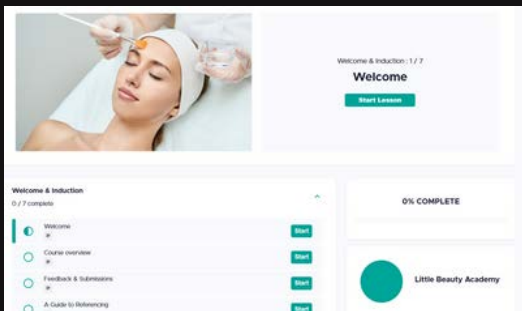

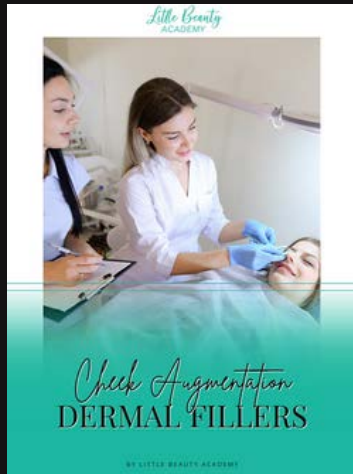
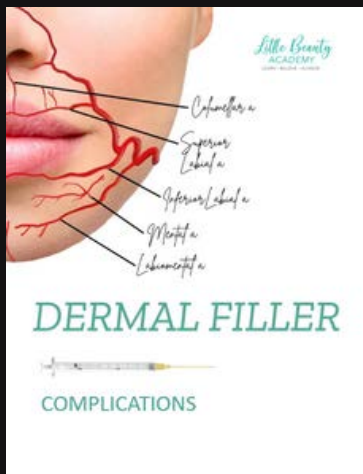
